The data we distributed as an attachment to your notice of recommended accreditation status dated November 19 contained some values that were not properly programmed. Namely, in categories where there were 0 applicable people for 2020-2021, the small group aggregation procedure was performed, rather than excluding the data, as is described in the ASEP manual. In addition, the small group aggregation for Indicator 4b at the All level was not conducted in the prior data.

Your accreditation rating of **Not Rated: Declared State Disaster** is not affected. Additionally, this does not change any other eligibility results that may have been calculated for your EPP. The revised data is attached.
